- cement in accordance with DIN EN 197-1
- trass in accordance with DIN 51043
- additives for regulating and improving workability and product properties

PROCESSING	
Temperature	■ Do not process or allow to dry out at air, material or substrate temperatures below +5°C, or if there is a risk of exposure to night frost, or at temperatures above +30°C, or in direct sunlight, or on heated up surfaces, and/or in windy conditions.
Mixing / Preparation / Processing	<ul> <li>The mixing ratios shown in the mixing table must be used when preparing the mortar. The amount of water required depends on the moisture content of the aggregate.</li> <li>Using a gravity mixer or compulsory mixer, mix with clean water to achieve the correct consistency.</li> </ul>
Processing	<ul> <li>Spread the freshly mixed mortar evenly across the prepared subsurface and compact the mortar.</li> <li>For dimensionally accurate natural stone or paving blocks, a screed gauge can be used in order to achieve the desired layer thickness.</li> <li>To improve bonding for natural stone, the underside of the blocks must be pre-coated with tubag bonding slurry.</li> </ul>
Processing / Working time	<ul> <li>Process mixed mortar within 2 hours.</li> <li>Mortar that has already started to harden must never be thinned down with additional water, remixed or applied.</li> <li>The stated times apply for a temperature of +20°C and relative humidity of 65%.</li> </ul>
Drying / Hardening	■ The fresh mortar is to be protected from rapidly drying out and unfavourable weather conditions such as frost, draughts, direct sunlight and direct driving rain.
Cleaning the tools	■ Clean all tools and equipment with water immediately after use.
Notes	<ul> <li>All the relevant construction standards, codes and regulations must be observed.</li> <li>Use only aggregates in accordance with DIN EN 13139, DIN EN 13055 or DIN EN 12620.</li> <li>The aggregates must not contain any colourants or harmful constituents.</li> </ul>
