Paving grout

2-component, synthetic resin bonded, slightly water-permeable paving stone grout mortar for heavy traffic loads

- can even be used in light rain, no covering required
- suitable for road sweeping machines
- compressive strength: $\geq 45 \text{ N/mm}^2$



APPLICATIONS

- for grouting existing and new paving
- suitable for use-category N3 according to ZTV Wegebau (extra technical requirements for road building)
- suitable for use in load class 0.3 RStO 12 (poss. also higher)
- For the production of cement- and water-free bedding and levelling mortar
- As bedding mortar for pavalable manhole covers

PROPERTIES

- low water permeability
- open-pored

SUBSTRATE

Properties/tests	<ul style="list-style-type: none"> ■ The paving and its subbase must be constructed in such a way as to prevent any loosening of the joints under subsequent loading. ■ The relevant regulations and instruction sheets for the construction of paving must be observed. ■ The entire construction must be water permeable, so that penetrating water can drain away. ■ Required minimum joint depth with small paving stones: 25 mm. ■ Required minimum joint depth with large paving stones: 30 mm. ■ Required minimum joint width: 5 mm ■ For large format tiles we recommend at least 5 mm or 1 % of the longest tile side as the joint width. ■ The sides of the paving units must be free of any impurities.
Pretreatment	<ul style="list-style-type: none"> ■ The paving surface to be joined should be carefully wetted before starting work to prevent the epoxy resin binder from penetrating the pores in the stones. ■ There must be no water standing in the joints. ■ Manhole covers that can be paved must be pretreated with strasser EG epoxy resin primer.

PROCESSING

Temperature	<ul style="list-style-type: none"> ■ Do not use or allow to dry and harden in air, material or substrate temperatures of less than +5°C, in the case of expected night time frost or at temperatures of over +25°C, in direct sunlight, extremely heated substrates and/or in strong wind.
Mixing / Preparation / Processing	<ul style="list-style-type: none"> ■ Mix both components for at least 3 minutes in a compulsory mixer or with a suitable mortar paddle. ■ Then add up to max. 10 % of clean tap water. ■ The optimal mortar consistency is reached when slight foaming appears.
Processing	<ul style="list-style-type: none"> ■ Grouting is done by slurring with a rubber squeegee. ■ Spreading as a slurry grout can be supported by a light water spray. ■ After approx. 10-15 minutes, the joints introduced are recompacted in a longitudinal and lateral direction with a medium-hard brush. ■ The film of binding agent remaining on the stones is then sprayed off with a water spray. ■ When used as bedding and levelling mortar no addition of water is required. Laying is carried out fresh in fresh. The underside of the paving elements must be coated with strasser EG epoxy resin primer before laying. The joints are also filled with PFV paving joint mortar, mechanically compacting the mortar to ensure a dense mortar structure.
Processing / Working time	<ul style="list-style-type: none"> ■ Approx. 20 minutes at +20 °C and 65 % relative humidity. ■ The processing time will be extended at low temperatures and/or high air humidity and shortened at high temperatures and/or low air humidity.
Drying / Hardening	<ul style="list-style-type: none"> ■ The freshly grouted area must be closed to traffic for at least 24 hours. ■ When working indoors, ensure good ventilation.
Cleaning the tools	<ul style="list-style-type: none"> ■ Clean all tools and equipment with water immediately after use.
Notes	<ul style="list-style-type: none"> ■ Optically related areas must be prepared with material from the same production batch to prevent colour differences. ■ In case of hail and heavy rain, the grouted area must be covered. ■ Any glossiness remaining on the surface of the paving after cleaning will weather away over time. ■ In the case of particularly light-coloured and porous types of paving block, the binder can cause certain effects such as a darkening of the colour. ■ In order to achieve an optimum appearance, we recommend that you first grout a sample area paved with the type of paving units in question. ■ Over time, some discolouration could take place due to the effects of dirt and weathering.

STORAGE

- Store in the original, unopened packaging in dry, frost-free conditions.
- We recommend that the product be used within 12 months of the date of manufacture.
